Using a Limited Purpose Flexible Spending Account (FSA) is great way to stretch your benefit dollars. You use before-tax dollars in your FSA to reimburse yourself for eligible out-of-pocket dental, vision and dependent care expenses. That means you can enjoy tax savings and increased take-home pay.

WHAT IS A LIMITED PURPOSE FSA?

With a LP FSA, you elect to have your annual contribution (up to) deducted from your paycheck each pay period, in equal installments throughout the year, until you reach the yearly maximum you have specified. The amount of your pay that goes into an FSA will not count as taxable income, so you will have immediate tax savings. FSA dollars can be used during the plan year to pay for qualified expenses and services.

- A Healthcare Limited Purpose FSA allows reimbursement of qualifying out-of-pocket dental and vision expenses.
- A Dependent Care FSA allows reimbursement of dependent care expenses, such as daycare) incurred by eligible dependents.

With all FSA account types, you'll receive access to a secure, easy-to-use web portal where you can track your account balance, view your account transactions, and submit requests for reimbursements.

WITH AN FSA YOU CAN:

- Enjoy significant tax savings with pre-tax deductible contributions and tax-free reimbursements for qualified plan expenses
- Enjoy secure access to accounts using a convenient Participant Portal available 24/7/365. When you enroll you will receive a "Next Steps Document" via email that includes detailed login instruction or call Admin America for assistance. You may access the portal via <u>www.adminamerica.com</u> and click on "Participants LOGIN".
- Manage your FSA "on the go" with an easy-to-use mobile app (see page 2 for more mobile app info)
- File claims easily online (when required) and let the system determine approval based on eligibility and availability of funds
- Stay up to date on balances and action required with automated email alerts and convenient portal and mobile home page messages

PORTAL ACCESS:

Go to www.adminamerica.com or directly at https://adminamerica.lh1ondemand.com/ . The first time you go to the site, click the login button on the participant Section. Your Username will be your first initial and last name followed by the last four digits of your social. The password is the word benefit followed by your Date of Birth in DDMMYY format (example: benefit081281). For privacy purposes, we recommend that you create a unique user name and password so that only you will know how to access your account information. Please feel free to give Admin America a call if you need assistance with this process.

IS AN FSA RIGHT FOR ME?

A LP FSA is a great way to pay for expenses with pre-tax dollars.

A Healthcare LP FSA could save you money if you or your dependents:

- Have out-of-pocket expenses like dental or vision plans
- Wear glasses or contact lenses or are planning LASIK surgery
- Need orthodontia care, such as braces, or have dental expenses not covered by your insurance

A Dependent Care FSA provides pre-tax reimbursement of out-of-pocket expenses related to dependent care. This benefit may make sense if you (and your spouse, if married) are working or in school, and:

- Your dependent children under age 13 attend daycare, after-school care or summer day camp
- You provide care for a person of any age whom you claim as a dependent on your federal income tax return and who is mentally or physically incapable of caring for himself or herself

PLAN AHEAD

Before you enroll, you must first decide how much you want to contribute to your account(s). You will want to spend some time estimating your anticipated eligible dental, vision and dependent care expenses for the plan year.

Be sure to estimate your expenses carefully as money left unspent in your FSA at the end of the year will be forfeited.

Be sure to check out the Mobile App available for your Android or iOS smartphone! The Mobile App makes account access and claim management easy and quick.





With the convenience of a mobile device, you can see your available balance anywhere, anytime as well as file claims and upload receipts.
